IATSE Local 495 *LOW-BUDGET* PAYROLL DEDUCTION CONSENT

Effective immediately, the undersigned assigns to I.A.T.S.E Local 495 two percent (2%) of all wages earned and to be earned by the undersigned employee, who is currently employed under a recognized low-budget agreement with IATSE local 495, and authorize and directs his/her employer to deduct such two percent (2%) from the undersigned's wages and to remit the same to I.A.T.S.E. local 495 as membership dues or, if not a member of I.A.T.S.E. Local 495, in payment of some percentage of the cost of operating the Union. This assignment shall be irrevocable for a period of either one (1) year, or until termination of the applicable *low-budget* collective bargaining agreements, whichever is sooner; and shall be automatically renewed, with the same irrevocability, for successive like periods unless terminated by the undersigned in writing to my then current employer and the local union not more than twenty (20) nor less than ten (10) days prior to the expiration of such period.

In signing this check-off authorization, I do so voluntarily, knowing that it is not a condition of employment. The Business Manager of IATSE local 495 is authorized to deposit this check-off authorization with any employer under a low-budget agreement with IATSE local 495, and is further authorized to transfer this authorization to any other employer under a low-budget agreement with IATSE local 495 in the event I should change employment. This payroll deduction consent is not conditioned on membership in the union.
